### **CAR Directors**

- Previously served or currently serving on the AAR Board of Directors
- Equivalent board and/or committee experience outside of the AAR including but not limited to CRMLS, LACBOR, AREA, NAHREP, NAGLREP, etc.
- Prior attendance at CAR business meetings
- Served as a member of different committees within the AAR
- Served as a Chair or Vice-Chair of various committees within the AAR
- General volunteerism within the AAR
- Being a member in good standing in the AAR
- A desire to give back to the AAR and the real estate industry
- A desire and willingness to share & apply wisdom and experience gained from the CAR and/or NAR meetings in an effort to better serve the AAR and its members
- Professionalism, honesty, integrity, and fair dealing among fellow Realtors®
- High moral, ethical and professional standards
- Strict adherence to the Realtor® Code of Ethics
- A desire to see the AAR grow and prosper

### **NAR Director**

- All of the above plus
- Prior experience as a CAR Director
- Prior attendance at an NAR meeting
- Leadership position(s) within CAR including but not limited to: Chair and Vice-Chair positions, Regional Chair, Strategic Planning and Executive Committee, among other leadership positions

### **Expectations and Responsibilities**

- CAR Directors: Punctuality and attendance at all 3 CAR meetings for the duration of the meetings and as required
- NAR Director: Punctuality and attendance at all 2 NAR meetings for the duration of the meetings and as required
- Additional meetings as required
- Willingness to serve on AAR committees that correspond to the CAR and/or NAR committee(s) on which you serve
- Willingness to make written and oral reports on your respective CAR and/or NAR committee(s)
- Financial contribution to the Realtor® Action Fund in a minimum amount of \$148
- A clear understanding that you may be out-of-pocket on meeting related travel costs
- A clear understanding that if you apply to CAR and/or NAR on your own for any positions AAR is under no obligation to reimburse you for your expenses
- Proper business attire at meetings (unless otherwise noted)
- A willingness to share your thoughts and ideas, sometimes in the face of controversy
- A willingness to place the AAR and AAR members first and above your own professional or personal gain
- Realizing that serving as a CAR Director and NAR Director is an honor and privilege

### **Development Committee**

- Shall comprise of a combination of 4 current CAR Directors and NAR meeting attendees with the Committee Chair being the current or most recent CAR Regional Chair from the AAR in addition to 5 AAR members at large
