TERMS AND CONDITIONS

- Lockboxes are to be leased at **\$9.95(plus tax)** per month.
- Minimum lease term is a standard CALENDAR QUARTER (ex. January - March)
- There will be no refunds, credits, or proration.
- \$25 cleaning fee will be applied if box is dirty upon return. (I.E. **NO PAINT, MUD/DIRT, WHITEWASH, GREASE, ETC.**)
- Lockboxes are to be in full working order when issued and returned.
- If a Lockbox has to be sent back for repair while in possession of Lessee, there will be a \$50.00 repair fee if not covered under warranty by Supra.
- Any Lockbox that is stolen, lost, or damaged during the lease period the lessee will be responsible to pay for the replacement of the Lockbox at a cost of \$95.00.
- Lockboxes are not to be sub-leased.

PENALTIES AND FEES

- It is your responsibility to pay your lease timely and before the quarter begins. If you fail to do so, you will be subject to MLS suspension and Supra key inactivation.
- We attempt to send courtesy reminders via email whenever possible, but this doesn't relieve your responsibility to remit timely payment.
- Your Broker will be notified after the 15th of the Quarter of all outstanding lockboxes.
- When batteries are low (less than 10%) the agent needs to remove and return the lockbox to AAR for an exchange. If the lockbox loses all power it is the lessee's responsibility to have it removed at the shackle and return it to AAR to be exchanged.
- A \$25 late fee will be applied to EACH individual Lockbox if not returned or extended by the due date.
